Blaxland Vineyards Limited, (the Responsible Entity) submits the Financial Statements of the project for the year ended 30 June 2004. The following persons held office as directors at any time during or since the end of the year unless otherwise stated.

Financial Highlights

The vineyard harvested its first crop during the year. The total harvest at 575.76 tonnes was below the Prospectus estimate of 877.5 tonnes due to the zero crop in the second stage plantings. The fruit was sold to the purchasers as per the various grape purchase agreements for an indicative value of \$586,602. The final crop total will be determined when weighted district average prices, applicable to some of the purchase agreements, are finalised in September. As was expected, the crop receipts did not fully cover the forthcoming year's maintenance fees and growers have been asked to contribute further funds to make up the shortfall.

Review of Operations

Advanced Viticulture and Management, an associate company of Blaxland Vineyards assumed the role maintaining the vineyard at Tanunda Hill in July 2003 and completed the construction phase of the vineyard which included the installation of a foliage wire throughout the vineyard, the construction of a chemical shed and wash down facility and the construction of all weather roads throughout the vineyard.

The vineyard is planted to Shiraz, Cabernet Sauvignon, and Merlot, together with small plantings of Petit Verdot, Temprenillo, Viogner and Sauvignon Blanc.

Principal Activities

The principal activity of the project is to develop a vineyard and grow and market grapes.
No significant change in the nature of these activities occurred during the year.

Distributions

No distributions were paid to growers during the period and no recommendation is made as to distributions.

Significant Changes in the State of the Affairs

There was no significant change in the state of the Project's affairs during the year.

Matters Subsequent to the End of the Financial Period

There are no matters or circumstances that have arisen since 30 June 2004 that have significantly affected or may significantly affect:

- the operations of the projects;
- the results of those operations; or
- the state of affairs of the project in subsequent financial years.

Likely Developments

At the time of writing this report, the whole vineyard had been developed and planted. We do not envisage acquiring further properties.

Environmental Regulation

The project's operations are not regulated by any significant environmental regulation under a law of the Commonwealth or of a State or Territory of Australia.

Options

No options over unissued interests in the project were granted during or since the end of the year and there were no options outstanding at the date of this report.

Interests Issued

No growers interests were issued during the year. There were 15 interests held by the responsible entity or its associates at the end of the financial year. There were no withdrawals from the scheme during the year. A total of 790 units have been issued in the scheme.

Fees Paid to the Responsible Entity

During the financial period \$2,964,414 (2003: \$2,833,218) was paid to Blaxland Vineyards Limited as fees to manage and develop the project. The total cost of the project for the financial period to 30 June 2004 was met from these funds as set out in the Prospectus.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards, Urgent Issues Group Consensus Views, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001.

The Accounting Standards have been consistently applied unless otherwise stated. The following specific policies have been applied consistently unless otherwise stated:

(a) Basis of accounting

These financial statements have been prepared on an accruals basis and in accordance with the historical cost convention, and do not take into account the changing values of money, or except where stated, current valuations of non-current assets. Cost in relation to assets represents the cash amount paid or the fair value of the asset given in exchange.

(b) Income and expenditure recognition

Income and expenditure belong to the individual growers.

Income is recognised by the project when the goods are provided. Expenditure is not recognised by the project until the project starts generating income. Once income is generated, all expenses are recorded in the project accounts as they are incurred.

(c) Income Tax

The Project is not a taxable entity under the Income Tax Assessment Act 1936.

(d) Cash

For the purposes of the statement of cash flows, cash includes cash on hand and in banks and money market investments readily convertible to cash within 2 working days, net of outstanding bank overdrafts.

(e) Trade and other creditors

These amounts represent liabilities for services provided to the economic entity prior to the end of the financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition.

(f) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

(g) Adoption of Australian Equivalents to International Financial Reporting Standards

Australia is currently preparing for the introduction of International Financial Reporting Standards (IFRS) effective for financial years commencing 1 January 2005. This requires the production of accounting data for future comparative purposes at the beginning of the next financial year.

The economic entity's management, along with its auditors, are assessing the significance of these changes and preparing for their implementation. An IFRS committee has been established to oversee and manage the economic entity's transition to IFRS. We will seek to keep stakeholders informed as to the impact of these new standards as they are finalised.

The directors are of the opinion that there are no key differences in the economic entity's accounting policies which will arise from the adoption of the IFRS.

Credit Risk

The maximum exposure to credit risk, excluding the value of any collateral or other security, at 30 June 2004 to recognised financial assets is the carrying amount of those assets, net of any provisions for doubtful debts, as disclosed in the statement of financial position and notes to and forming part of the financial statements.

The Project does not have any material credit risk exposure to any single debtor or group of debtors under financial instruments entered into by the Project.

Net Fair Values

The net fair value of assets and liabilities approximates their carrying value. No financial assets and financial liabilities are readily traded on organised markets in standardised form other than listed investments. Financial assets where the carrying amount exceeds net fair values have not been written down as the Project intends to hold these assets to maturity.
